STIPEND

A stipend is a monthly payment provided to you to cover living and miscellaneous expenses. All Ph.D. students are provided a 50% stipend. Stipends are provided for fall, winter, spring/summer terms for a maximum of 4 years. The fifth year stipend is only awarded for fall and winter terms.

HEALTH INSURANCE (GRADCARE)

All Ph.D. students and any dependents are provided health insurance during fall, winter and spring/summer terms of your entire program of study. Taubman College also covers your partner and dependents, if applicable.

GSI TEACHING REQUIREMENTS

One fall or one winter semester for each of the first 5 years will have a GSI teaching requirement.

This is determined based on annual teaching needs.

DISCLOSURES

All such awards are contingent upon satisfactory completion of program requirements in a timely fashion. The University requires background checks for all individuals who have an appointment or employment at the University. Because your funding offer includes your appointment as a Graduate Student Instructor (GSI) or Graduate Student Research Assistant (GSRA), and/or Graduate Student Staff Assistant (GSSA), a background check prior to your first appointment in any one of these positions is needed. Your funding commitment is contingent upon the successful completion of a background check, which includes the successful resolution of any issues that might arise, prior to the commencement of your first appointment.

Changes to funding/support are not retroactive.

If you defend in the spring/summer, there is no Taubman College funding offered.
